## METRICH/Crawford County sheriff's raid nets drugs, cash and two arrests

Crawford County

Deputies from the Crawford County Sheriff's Office and the METRICH Enforcement Unit seized suspected drugs, cash, and drug paraphernalia and made two arrests on Friday at 912 Sherman St.

Law enforcement officials served a narcotic search warrant at the conclusion of an investigation into illegal narcotics being used and sold from the property.

Arrested was Amanda L. Hill, 42, and Robert G. Bowersock, 50, according to the Crawford County Sheriff's Office.

Deputies seized suspected methamphetamines, psilocybin mushrooms, marijuana, currency, prescription medication and drug paraphernalia, according to a news release from the sheriff's office.



Both individuals were taken to the Crawford County Justice Center. Bowersock was later released. Reports will be forwarded to the Crawford



County Prosecutor's Office for consideration of charges, the sheriff's office said.

This case is still being investigated by the detectives from the sheriff's office.

#### **435 grams of methamphetamine seized in Mansfield traffic stop** *Richland County*

A Mansfield traffic stop led to the seizure of 435 grams of methamphetamine and the arrest of the driver, the METRICH Enforcement Unit confirmed.

METRICH said its detectives conducted an illegal drugs investigation into the Mansfield community on Jan. 5.

The traffic stop in the 600 block of South Diamond Street resulted in the methamphetamine seizure by METRICH detectives and Mansfield Police Patrol, according to METRICH.

METRICH identified the driver as 21-yearold Elijah Myers, who was charged with felony drug possession and is being held



at the Richland County Jail.

The case is being presented to the Richland County Prosecutor's Office for further charges, according to METRICH.

METRICH Lt. Steve Blust stated that this was a direct result of cooperation amongst partner law enforcement agencies and tips received from the community.

Lt. Blust encourages the community to continue reporting suspected drug activity to help the METRICH Enforcement Unit to continue to "seek those that pollute our streets with narcotics."

### **2 arrested after drug task force raids Findlay apartment** *Hancock County*

On Wednesday evening, the Hancock County METRICH Drug Task Force, the Findlay Police Department Emergency Response Team, and Findlay Fire Department Tactical EMS executed a search warrant at 345 E. Sandusky St. Apt. B in Findlay, Ohio.

The search of the residence yielded methamphetamine, numerous prescription pills, marijuana and THC products, as well as a large amount of drug paraphernalia. Other items indicative of drug trafficking were also seized, according to a press release from METRICH.

The evidence substantiated the ongoing investigation into the residence for suspected drug possession and drug trafficking.

As a result of the search, Davina M. Martinez, 45, and James K. Rhine, 46, were arrested and taken to the Hancock County Justice Center. Martinez and Rhine are residents of 345 E. Sandusky St. Apt. B in Findlay, Ohio. They were both charged with possession of methamphetamine. Martinez was charged with a third-degree felony and Rhine was charged with a fifth-degree felony, according to the release.

Additional charges of drug trafficking and drug possession are expected at the conclusion of the investigation, according to the release.

The Hancock County MET-RICH Drug Enforcement Unit is supported by METRICH in Mansfield, Ohio, and funded in part by the Office of Criminal Justice Services. The investigation is ongoing

### **Drug Task Force make major drug bust inside a Tiffin home** Seneca County

The Seneca County Drug Task Force, along with the Seneca County Sheriff's Office, the Tiffin Police Department and Seneca County Probation Services executed a drug-related search warrant at a home in the 100-block of 8th Avenue Friday.

Inside, authorities found what they describe as large amounts of methamphetamine, cocaine, fentanyl, marijuana, THC products and criminal tools. The home, which belongs to Jessie J. Jarvis, Sr., 46, of Tiffin, is currently in the Seneca County Jail for an unrelated probation violation stemming from previous charges of improper handling of a firearm, failure to comply with signal of a peace officer and aggravated possession of drugs. Authorities say additional charges of trafficking in cocaine, methamphetamine, fentanyl and THC, along with possession of criminal tools could be added pending the outcome of the investigation.

Three others were found inside the home. Charges could be pending against them once the results of laboratory analysis of the suspected narcotics discovered inside the home come back.

"Mr. Jarvis has been on our radar for quite some time," Unit Coordinator Brandon Bell with



the Seneca County Drug Task Force said. "Apparently being out on judicial release and on probation supervision is not enough for Jessie to get the message to walk the straight and narrow. We hope he gets the message now."

#### **Crawford County Special Response Team execute search warrant** *Crawford County*

On January 27, 2023, the Crawford County Sheriff's Office -METRICH concluded a severalmonth narcotics investigation at 1220 N. Sandusky Ave. Bucyrus, Ohio. The Crawford County Special Response Team (SRT) executed the narcotic search warrant. The SRT consists of members of the Sheriff's Office, Bucyrus Police Department, Crestline Police Department, Galion Police Department, and New Washington Police Department, along with the Bucyrus and Galion Fire Departments.

The target of the investigation

was Zachary McIntyre, age 32, and Stevena Gruber, age 43, who resides at this address.

Methamphetamine, prescription pills, Psilocybin mushrooms, and drug paraphernalia were seized from the residence. Seven adults and four children were living inside this residence. The adults were all detained and brought to the jail until Detectives could interview them. McIntyre and Gruber remain in the Justice Center, and the rest were released. They will both be facing drug trafficking charges, Possession of Methamphetamine, and Gruber was also charged with illegal conveyance into a detention facility.

This report will be forwarded to the Crawford County Prosecutor's Office for review and consideration of additional charges. Bucyrus Police Department, along with Bucyrus Fire Department, assisted at the scene. Children Services was also called to the scene due to the children at the residence. The Crawford County dog warden was contacted for the dog.

#### Joint operation leads to drug-related arrest of Findlay woman Hancock County

A joint operation led by the Hancock County METRICH Drug Task Force resulted in the arrest of a 35-year-old woman on drug-related charges Tuesday.

According to the authorities, the team, consisting of the Hancock County Sheriff's Office, the Findlay Police Department, and the SPCA of Hancock County, executed a search warrant at a residence located at 614 Putnam St., Findlay, Ohio.

The search yielded approximately 2.5 kilograms of marijuana, 34 grams of psilocybin mushrooms, 226 grams of hashish wax, 461 THC vape pens and cartridges, 59 packages of THC edibles, and \$1,667 in cash. Also found were several items of paraphernalia and items indicative of drug trafficking, according to a press release from METRICH.

As a result of the operation, Brittany M. Hill, 35, was arrested and taken to the Hancock County Justice Center. She faces charges of possession of marijuana, possession of psilocybin, and possession of THC wax — all of which are third-degree felonies. The SPCA of Hancock County also cited Hill for some animal violations, but it is unclear what those violations entail. Additional drugrelated charges are expected to be filed at the conclusion of the investigation, according to the release.

The authorities did not release any further information about the case, and it is not clear whether anyone else was involved.

### **Tiffin man arrested after traffic stop leads to discovery of drugs** Seneca County

A Tiffin man was arrested Tuesday after authorities executed a search warrant on his vehicle during a traffic stop on County Road 54.

The Seneca County Drug Task Force – METRICH Enforcement Unit, along with additional units from the Seneca County Sheriff's Office and the Tiffin Police Department, executed the search warrant on a vehicle driven by 58year-old Jeffery S. Collins, of Tiffin.

The search unveiled suspected methamphetamine and U.S. currency, according to a press release from METRICH.

Collins was arrested at the sce-

ne for possession of methamphetamine and possession of criminal tools. All charges are pending laboratory analysis and the conclusion of the entire drug investigation.

A subsequent search of Collins' residence, located at 686 S. Sandusky St., Lot #79, Tiffin, unveiled drug paraphernalia and criminal tools, according to the release.

"The collaborative efforts of the drug task force, Tiffin Police Department, and Seneca County Sheriff's Office were on full display this evening," Seneca County Sheriff Fred Stevens said in the release. "As always I would en-



courage citizens to continue to report suspicious activity to their local agencies or the Seneca County Drug Task Force – METRICH Enforcement Unit drug hotline at (419) 443-0463."

#### Authorities seize nearly 1,000 grams of fentanyl in drug raids Marion County

Agents from the METRICH-MARMET Drug Task Force and other law enforcement agencies seized nearly 1,000 grams of fentanyl during a midweek raid, which was the culmination of what officials are calling "a major drug trafficking investigation."

Major Chris Adkins of the Marion Police Department and the METRICH-MARMET Drug Task Force said local law enforcement agents in concert with agents from the Cleveland and Cincinnati offices of the FBI executed search warrants at four locations on Wednesday in Marion and Morrow counties. He said the raids netted a total of 941 grams of suspected fentanyl, three firearms, and drug paraphernalia.

Agents arrested Christopher B. Payne Jr., age 24, Marion, who was charged with two counts of trafficking in a fentanyl-related compound, both first-degree felonies, when he appeared in Marion Municipal Court. Bond for Payne was set at \$5 million. He is being held at the Multi-County Correctional Center in Marion. He is scheduled to appear in municipal court for a preliminary hearing at 8:30 a.m. on March 24, according to online court records.

Adkins said agents executed search warrants at a residence in the 800 block of Adams Street in Marion, a residence in the 800 block of Central Drive in Marion, a residence in the 600 block of Pearl Street in Marion, and a residence in the 5000 block of Township Road 59 in Mount Gilead. Payne was arrested at the Pearl Street residence, Adkins said.

"This is an ongoing investigation," Adkins said. "This is a very significant seizure of fentanyl. On average, two milligrams of fentanyl can be lethal, so with the amount that we seized, it could kill approximately 470,000 people. We're losing a lot of people to fentanyl. In Marion County, we lose an average of 40 people a year to fentanyl. For a community our size, the number of deaths that we have from fentanyl is staggering."

According to the affidavit filed in support of the arrest warrant for Payne, he allegedly sold fentanyl to confidential informants on two occasions in December 2022 and January 2023. In the affidavit, Det. Stacy McCurry of the MET-RICH-MARMET Drug Task Force stated that on Dec. 28, 2022, Payne allegedly "sold fentanyl to a confidential informant, who was working with the MET-**RICH-MARMET** Drug Task Force. (Payne allegedly) supplied the fentanyl to the confidential informant for \$680. The suspected fentanyl that (Payne allegedly) sold was tested by the Mansfield Police Crime Lab and was found to be 49.64 grams of a substance This containing fentanyl. is enough fentanyl to kill nearly 25,000 people."

McCurry said the second inci-



dent occurred on Jan. 10, 2023, when Payne allegedly "sold fentanyl to a confidential informant, who was working with the METRICH-MARMET Drug Task Force. (Payne allegedly) supplied the fentanyl to the confidential informant for \$780. The suspected fentanyl that (Payne allegedly) sold was tested by the Mansfield Police Crime Lab and was found to be 26.74 grams of substance containing fentanyl. This is enough fentanyl to kill nearly 13,000 people."

Adkins said the Marion Police Department, Marion County Sheriff's Office, Morrow County Sheriff's Office, Wyandot County Sheriff's Office, Marion County Prosecutor's Office, and the U.S. Attorney for the Northern District of Ohio were all involved in the investigation and subsequent raids on Wednesday.

#### **Games parlor raided** *Hancock County*

Lucky Dragon Internet Cafe was raided by local law enforcement agencies Monday afternoon.

The Hancock County MET-RICH Drug Task Force, Findlay Police Department, Hancock County Sheriff's Office, Ohio Investigative Unit and city of Findlay Street Department executed a search warrant at the cafe about 1:50 p.m. The search warrant stemmed from an ongoing investigation into numerous citizen complaints about the 1107 Tiffin Ave. business, according to a release from METRICH Drug Enforcement Unit.

Complaints included the use and sale of illegal narcotics by patrons within the business, a survived overdose and illegal cash payouts via gaming machines operated inside the cafe.

Seized from the business were 60 electronic video gaming devices, four large tabletop gaming devices, a "Queen of Hearts" gaming board with payouts and a total of \$53,047 cash from gaming devices, payout machines and busi-

ness profits.

The owner of the Lucky Dragon Internet Cafe could face charges of gambling and operating a gambling house pending the outcome of the investigation.
