

Search warrants net three arrests, various drugs

Three men are facing charges in connection with alleged drug trafficking in Marion County.

According to a press release the MARMET Drug Task Force, local law enforcement agencies executed warrants on Monday, July 13 and Tuesday, July 14, at locations in the Marion area and arrested Peter L. Harris, 21, Chicago; Dedrick J. Lampkin Jr., 30, Marion; and Dontrell M. Anderson, 35, Marion.

Marion County Sheriff's deputies arrested Harris around 4:16 p.m. on Monday at a residence in the 200 block of Leader St., Marion. Deputies seized 51 grams of fentanyl that Harris allegedly had in his possession at the time of his arrest.

According to the sheriff's office incident report, deputies also seized \$29.40 in cash, an electronic device, and other items that were not specifically identified.

Harris is being charged with possession of fentanyl, a first-degree felony, according to Marion Municipal Court records. Bond was set at \$250,000. His case was filed with the court on Thursday.

Harris is scheduled to appear at a preliminary hearing in municipal court at 8:30 a.m. on Friday, July 24.

Lampkin was taken into custody around 9 a.m. Tuesday by officers from the Marion Police Department at a residence in the 600 block of Wilson Ave., Marion. Officers seized a firearm, pills, and mushrooms that Lampkin allegedly had in his possession at the time of the arrest.

According to the Marion Municipal Court website, Lampkin's case was filed with the court on Wednesday. He is being charged with two counts of aggravated possession of drugs, one of which is a third-degree felony while the second is a fifth-degree felony; having weapons while under disability, a third-degree felony; and possession of drugs, a fifth-degree felony. Bond was set at \$25,000.

Lampkin is scheduled to appear at a preliminary hearing in municipal court at 8:30 a.m. on Friday, July 24.



Marion Police arrested Anderson around 2:57 p.m. Tuesday at a residence in the 500 block of Pearl St., Marion. Officers seized 213 Oxycodone pills that Anderson allegedly had in his possession at the time of the arrest.

According to the Marion Municipal Court website, Anderson's case was filed with the court on Wednesday. He is being charged with aggravated possession of drugs, a second-degree felony; tampering with evidence, a third-degree felony; and possessing criminal tools, a fifth-degree felony. Bond was set at \$75,000.

Anderson is scheduled to appear at a preliminary hearing in municipal court at 8:30 a.m. on Friday, July 24.
